Consignment Terms & Conditions

- 1. AUCTION SALE: Consignor agrees to pay a commission to Dutch Country Auctions for its services equal to the above noted percentage of the "hammer price" for each lot sold. Lots will be sold to the highest bidder at one increment over the second highest bidder. There will be a minimum commission fee of \$25.00 for all lots, whether sold or unsold.
- 2. LOTTING: Dutch Country Auctions may offer the material in lots or groupings it deems appropriate and describe and evaluate the material in a manner that Dutch Country Auctions determines to bring the best results. Material which is deemed of little value or not appropriate for auction will be returned. No warranty is expressed or implied that material sold at auction will bring any specified or estimated price or that Dutch Country Auctions will establish any minimum or reserve price. Owner acknowledges that auction prices are generally substantially less than catalog prices and may be less than auction price estimated.
- 3. NOTIFICATION: Approximately 5 weeks before the sale, consignors will receive a detailed listing of consigned lots along with a copy of the printed auction catalog.
- 4. WITHDRAWAL OF LOTS: Requests to withdraw consigned lots after the catalog has been published shall be withdrawn at the discretion of Dutch Country Auctions and at a charge to the owner of \$55 per lot plus shipping expenses.
- 5. CONSIGNOR RESERVES: Reserves requested by the consignor may be placed on some lots at the discretion of Dutch Country Auctions. If a lot does not sell due to the consignor's reserve, the lot will be returned and the consignor will be charged \$55 per lot as well as shipping expenses.
- 6. EXPENSE OF RETURN: Dutch Country Auctions reserves the right to return material if it does not meet its standard (or if it is not sold) and reserves the right to make returns at Owner's expense.
- 7. PRELIMINARY RESULTS: Notification will be sent to consignors within 14 days following the auction. These results are unofficial as there is the possibility lots may be returned, placed on extension, or corrected.
- 8. SETTLEMENT: Payment will be made 45 business days after the auction date. There may be delay in items sent to an expertization service and payment will be made promptly when the item has been cleared.
- 9. LIMITATION OF LIABILITY: In the event of any loss or damaged material while in the possession or control of Dutch Country Auctions, its agents or employees, Dutch Country Auctions liability for such loss shall be limited to the amount specified as the insurance value of the material (or if no such value is specified, the wholesale value of the material), and Dutch Country Auctions shall have no liability in excess of the aforementioned amount, whether such loss or damage shall be due to the negligence of Dutch Country Auctions, its agents or employees, or due to any other cause whatsoever.

These terms will apply for current consignment and all future consignments though maybe subject to change at our discretion.
